IV. MANAGERS REPORT (Madden)

A. Conservancy Taxes

 Monroe County taxes have been sent out and include two years of Conservancy taxes. 2006 pay 2007 and 2008 pay 2009.

July 27, 2009

 Brown County taxes have not yet been sent. Auditor anticipates Brown County taxes for 2007 pay 2008 to be mailed in July.

B. Jackson Township Fire Department: Update

 Jackson Township Fire Department will continue to be called out for 911 emergencies. The fire department has also received a contract to continue operation.

C. 2009 Vegetation Control: Update

 Rain has decreased water transparency, thus sunlight, reaching the vegetation. Winter drawdown has had a positive effect in reducing weed growth. Aquatic Control, Inc will do an initial weed survey in July.

D. 2009 Debris Removal: Update (East End- Long Causeway)

Debris along the causeway has been removed.

E. Fireworks Show: Update

- Fireworks scheduled for Friday, July 3rd.
- \$4,165 has been collected in donations to date.

F. Lake Patrol: Update

- Lake Patrol will be present regularly on the lake.
- Patrol will begin issuing citations as of June 27th 2009.

V. SEDIMENT REMOVAL PROGRAM- UPDATE & BOARD ACTION (MANN)

Mann summarized the current status of the Sediment Removal Program. The next
phase is to prepare bidding specifications for the eventual purchase of a Barge,
Push Boat, Excavator, Off-road carrier truck and Utility truck. Director Schell
expressed his belief that hydraulic dredging may be a better alternative to
mechanical dredging.

July 27, 2009

- Public concerns include the lack of an east-end disposal site, and the LLCD's ability to manage a mechanical dredging operation.
- FOR THE RECORD- Freeholders Spencer & Jill Leiter are concerned about the
 possibility of rezoning the current sediment disposal site so freeholder Ken Clark
 could sell the sediment. Rezoning would further depreciate their property values.
- The Board asked management to meet with the Leiter's to discuss ways to improve the aesthetics of the disposal site.

FRIESEL MOTIONED TO AUTHORIZE CONSERVANCY MANAGER MADDEN TO GET WITH ANGELA PARKER, LLCD ATTORNEY TO PREPARE BIDDING SPECIFICATION PACKAGE FOR THE SEDIMENT REMOVAL PROGRAM. RITTER SECONDED THE MOTION. SIX "AYES", ONE "NAY" (JOHN SCHELL). MOTION CARRIED.


