I. OPENING COMMENTS (Mann)

A. Report of Claims

B. Dredging Equipment Loan Update and Recommendation

Friesel has met with multiple banks to discuss equipment loan.

IV. FIREWORKS PROPOSAL: SKY MAGIC PYROTECHNICS, INC. (MANN)

- Lake Lemon will be changing fireworks providers as previous company's ATF license was not renewed.
- Recommended show option will include approximately 25 minutes and have shots every 2 to 3 seconds.
- This year's fireworks show will be held on Saturday, July 3rd with a rain date of Sunday July 4.

CASSAL MOTIONED TO APPROVE 2010 FIREWORKS CONTRACT WITH SKY MAGIC PYROTECHNICS, INC. FOR SUM OF \$6,500. DUGAN SECONDED THE MOTION. ALL"AYES." MOTION CARRIED

V. LAKE RESTORATION PROJECT (MANN)

- IU SPEA Professor, Bill Jones has been hired as a consultant to work with the City of Bloomington Utilities and organizations of interest for accrual of new sediment disposal sites.
- Disposal sites of interest include 2 sites. One near Possum Trot Rd. and one on the Little Africa peninsula.
- Madden stated Bill Jones will attend the Board's April Meeting.

VI. WEBSITE RECONSTRUCTION DISCUSSION (MANN)

- The LLCD website is getting outdated and needs to be updated both in content and design.
- Madden, Mann, and Casey have met with a web developer from BlueTide Productions, LLC and discussed the current webpage and what they would like to see done with it.
- The web developer estimated that the website reconstruction would take approximately 3 to 4 weeks and cost \$750 to \$1000.

• Madden said he would arrange to have potential vendor attend the Board's April Meeting.

VII. MANAGERS REPORT (MADDEN)

- a) Conflict of Interest policy
 - Forms were discussed and signed by Board Members and Manager.
- b) Safety Program Manual
 - Board members reviewed and discussed the new Safety Program Manual.

SCHELL MOTIONED TO APPROVE OCCUPATIONAL DRUG AND SAFETY MANUAL AS WRITTEN. CASSAL SECONDED THE MOTION. ALL "AYES". MOTION CARRIED.

- c) Seasonal Job Descriptions- Barge Operator, Push Boat Operator and Maintenance Technician.
 - Job descriptions were updated to include seasonality, use of new equipment and need for safety manual due to inherent job safety concerns.
- d) Boating Safety
 - Lt. Jason Lee will be in charge of conservation officers and would like to increase presence at Lake Lemon.
 - Conservation officers would like access to the LLCD patrol boat and permission to store a DNR personal watercraft at Riddle Point Park.
 - Schell wanted to note that DNR law enforcement presence at Lake Lemon is at the invitation of the LLCD Board of Directors.

HOBSON MOTIONED TO APPROVE CONSERVATION OFFICER USE OF LLCD PATROL BOAT AND PERMISSION TO STORE A PERSONAL WATERCRAFT AT RIDDLE POINT PARK. FRIESEL SECONDED THE MOTION. ALL"AYES". MOTION CARRIED.

- e) Lake Lemon Triathlon Proposal
 - The 2nd Annual Lake Lemon Triathlon has been proposed to take place at Riddle Point Park on September 18, 2010.
 - The sponsoring organization, IU's Phi Kappa Psi Fraternity, requested that no bass tournaments be scheduled on the day of the event.

• They are willing to compensate the District to offset loss of revenue for not having a bass tournament.

SCHELL MOTIONED TO ALLOW TRIATHLON TO BE SCHEDULED FOR SATURDAY, SEPTEMBER 18, 2010 AND TO NOT SCHEDULE A BASS TOURNAMENT ON THAT DATE. TOURNAMENTS WILL BE ALLOWED ON SUNDAY, SEPTEMBER 19, 2010. CASSAL SECONDED THE MOTION. ALL "AYES". MOTION CARRIED.

 - Riddle Point Park boat ramp opened March 20th.


